Brassicas	Apply only where known deficiency exists	2-3	400-800	1-2
Cereals	As necessary from 2-6 leaf stage to GS32	2-4	400-800	As required
Citrus	Apply in 400-800 litres of water depending upon tree size. Repeat in line with growth flushes every 3 months	2-4	400-800	3-6
Leafy Salads	As required from tissue analysis. Repeat at 10-14 day intervals	1-2	400-800	As required
Legumes	Repeat as necessary at 14 day spray intervals	2-3	400-800	As required
Ornamentals	As required from tissue analysis. Repeat at 10-14 day intervals	1-2	400-800	As required
Potatoes/Root Crops	As required from tissue analysis. Repeat at 10-14 day intervals	2-3	400-800	As required
Soft Fruit	As required from tissue analysis. Repeat at 10-14 day intervals	1-2	400-800	2-4
Sugar Beet	1st 4-6 leaf stage. 2nd 8-12 leaf stage	2-4	400-800	2
Top Fruit	Apply in 400-800 litres of water depending upon tree size. Apply after petal fall repeat at 10-14 day intervals	2-3	400-800	As required
