|-------------------------------------|---|-------------|---|
| Broad Beans                         | Apply up to early pod formation   | 2           | 200-400                                 |
| Carrots                             | Apply 2-3 weeks after emergence up to commencement of storage root growth   | 1-2         | 200-400                                 |
| Cereal                              | Apply before GS 32  | 0.5-1       | 200-400                                 |
| Field Beans                         | Apply from 4 nodes up to early pod formation  | 2           | 200-400                                 |
| Maize                               | Apply between 4 and 8 leaf stage  | 1-2         | 200-400                                 |
| Nursery Stock (Bedding/Pot Plants)  | Apply as soon as leaf canopy is sufficiently mature, repeat at 2-3 week intervals or as required  | 2-4 ml/l    | High volume foliar spray or root drench |
| Oilseed Rape                        | Apply from 2 leaf stage up to early stem elongation stage   | 1-2         | 200-400                                 |
| Onions/Leeks                        | Apply between 3 to 6 true leaf stage  | 2           | 200-400                                 |
| Ornamentals (Roses/Christmas Trees) | Apply as soon as there is sufficient leaf canopy and repeat at 2-3 week intervals or as required  | 4           | 600-1000                                |
| Peas                                | Apply at 1 l/ha in 200-400 l/ha water between 2 fully expanded leaves up to 3 pairs of fully expanded leaves and/or at 1-2 l/ha in 200-400 l/ha water from flower bud formation up to early pod formation | N/A         | N/A                                     |
| Potatoes                            | Apply 7-10 days before flowering or when tubers are between 0.6 and 2.5cm in diameter and again 3-5 weeks later   | 2.5         | 200-600                                 |
| Swedes/Turnips                      | Apply between 6 and 10 leaf stage   | 1-2         | 200-400                                 |
| Vegetable Brassicas/Lettuce/Herbs   | Apply between 6 and 8 true leaf stage   | 1-2         | 200-400                                 |
